The Velocity Global Wallet® Swipe and Win Points Giveaway Conditions of Entry

A. General

1. Information on how to enter this Promotion, mechanics of entry and prizes form part of these Conditions of Entry. Entry into this Promotion is deemed acceptance of these Conditions of Entry by each Entrant.
2. Entry is open to Velocity Frequent Flyer members who are Australian residents and aged 18 years or over. The Promoter is Velocity Frequent Flyer Pty Ltd (ACN 601 408 824) of registered address 56 Edmondstone Road, Bowen Hills, Queensland 4006.
3. B. Entry

5. Entrants will be automatically entered into the Promotion when they spend internationally on a Qualifying Purchase using their Global Wallet® card during the Promotion Period. Entrants will receive 1 entry every time they make a Qualifying Purchase with merchants located outside of Australia using their Global Wallet® during the Promotion Period. Qualifying Purchases exclude ATM withdrawals, quasi cash transactions (e.g. money orders, travellers' cheques and foreign currencies in cash), payments made to the Australian Taxation Office or other national or local Australian tax authorities, fees and charges, account adjustments, reversed transactions, gambling transactions and business transactions. 6. Bonus Points will be allocated to your Velocity account no earlier than the first day of the month that is at least 30 days after the Promotion Period end date.

Entrants who have activated their Global Wallet® account but have never loaded any funds onto their Global Wallet® nor made a Qualifying Purchase using their Global Wallet® card as at the commencement of the Promotion Period, will receive a once off 500 bonus Velocity Frequent Flyer Points when they complete one or more Qualifying Purchases with a total minimum value of AU\$100 (equivalent) with a merchant located outside of Australia, during the Promotion Period.
